Draw	Type of draw: fixed prize
	Number of tickets available for sale: 1,250 (first number: 0001 Last number: 1,250)
	Sale price for each ticket: \$50 Place where the tickets are sold: Any Quebec resident aged 18 or older may purchase tickets by filling out the online entry form. The tickets must be paid by credit card.
	Dates of ticket sales: from September 25 to December 3, 2024, 1 p.m.
	Place, date and time of the draw: The draw of the three prizes will take place at 3 p.m. on December 9, 2024 at the Foundation of Quebec Chartered Professional Accountants, 5 Place Ville Marie, suite 800, Montreal, Quebec H3B 2G2
	Procedure for selecting the winners:
	The draw will be supervised by an accounting firm.
	• The chances of winning one of the three prizes are directly related to the number of entries received.
	• Three tickets will be drawn among all entries received in the order presented in the description of the "Prizes."
