The tickets must be paid by credit card.</p> <p><b>Dates of ticket sales:</b> from September 25 to December 3, 2024, 1 p.m.</p> <p><b>Place, date and time of the draw:</b> The draw of the three prizes will take place at 3 p.m. on December 9, 2024 at the Foundation of Quebec Chartered Professional Accountants, 5 Place Ville Marie, suite 800, Montreal, Quebec H3B 2G2</p> <p><b>Procedure for selecting the winners:</b></p> <ul style="list-style-type: none"> <li>• The draw will be supervised by an accounting firm.</li> <li>• The chances of winning one of the three prizes are directly related to the number of entries received.</li> <li>• Three tickets will be drawn among all entries received in the order presented in the description of the "Prizes."</li> <li>• A participant cannot win more than one prize.</li> </ul>
