



FAQ – Assistance towards success scholarship

If you have doubts or questions, you are responsible for contacting the [Foundation](#) before the deadline for submitting your application.

I am enrolled in one of the recognized bachelor's degree programs or the equivalent, but I do not have a minimum grade point average of 2.8/4.3. Can I submit my application?

- Unfortunately, you are not eligible.

I am enrolled in one of the recognized bachelor's degree programs, but I will have not completed 15 credits by the competition deadline. Can I submit my application?

- Unfortunately, you are not eligible.

I am enrolled in one of the recognized bachelor's degree programs and have completed 15 or more recognized credits from a DEC-BAC. Can I submit my application?

- If your transcript shows a minimum of 15 completed credits **and** a grade point average of 2.8/4.3, you may be eligible to apply.
- If your transcript shows a minimum of 15 completed credits, but not a grade point average, you are not eligible.

The transcript in my possession does not show the courses and/or my grade point average for the most recent session I completed. Can I submit my application?

- If your transcript does not show any of the required information, we suggest that you wait as close as possible to the deadline to submit an updated transcript that has all the required information.
- If you are unable to submit the requested information, you are not eligible.

The transcript in my possession does not show the courses that I am taking in the session when the competition deadline falls. Can I submit my application?

- If your transcript does not show any of the required information, we suggest that you wait as close as possible to the deadline to submit an updated transcript that has all the required information.
- You can also attach a recent document from the registrar's office that specifies all of the required information.
- If you are unable to submit the requested information, you are not eligible.

I am enrolled in a university graduate program and am waiting for confirmation of my registration with the Order and/or for courses at my university. Can I submit my application?

- We suggest that you wait as close as possible to the deadline to submit the required documents.
- You can also attach documents from the Order that prove your registration and/or documents from your university's registrar's office that specify the required information.
- If you are unable to submit the requested information, you are not eligible.

I am enrolled in the National Program and am waiting for confirmation of my registration with the Order and/or for module(s). Can I submit my application?

- We suggest that you wait as close as possible to the deadline to submit the required documents.
- You can also attach a document from the Order that specifies the required information.
- If you are unable to submit the requested information, you are not eligible.

I will have already completed the CPA Professional Education Program (PEP) by the competition deadline. Can I submit my application?

- To submit your application, you must not have already finished the PEP by the competition deadline, i.e. be eligible to write the Common Final Examination or have already written it.

I have to retake PEP courses (University Graduate Program or National Program) to write the CFE again. Can I submit my application?

- Unfortunately, you are not eligible because you have already successfully completed the PEP.
